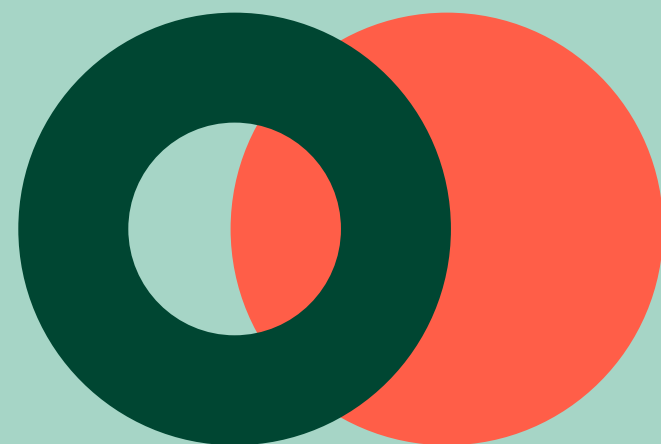

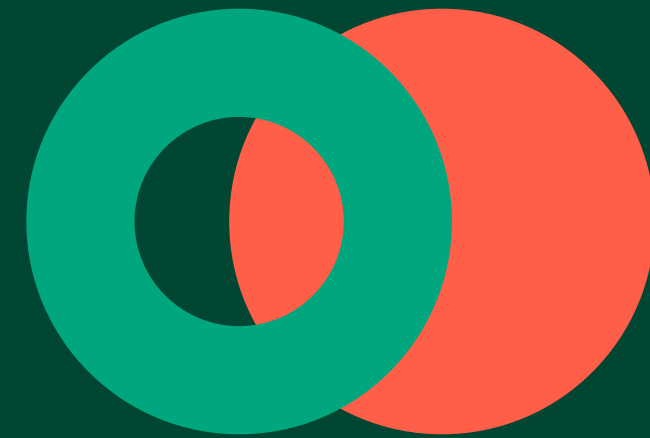

OUTCOMES OF COP28 IN DUBAI

- A historical result on the first Global Stocktake. Strong outcome on energy transition including
 - Transitioning away from fossil fuels
 - Tripling renewable energy capacity globally and doubling the global average annual rate of energy efficiency
- Global Stocktake delivered direction for next round of Nationally Determined Contributions (NDCs)
- Adopting the adaptation framework and launched the new Loss and Damage fund



COPENHAGEN CLIMATE MINISTERIAL



- Third year DK hosted CCM. Participants from all regions, observers, relevant actors.
- The ministerial has been established as a part of the international climate calendar and kicks off the year.
- Collaboration with COP-Presidencies.
- Agenda this year: Implementing Global Stocktake and decisions from COP28, new climate finance target, and NDCs

EXPECTATIONS FOR THE NEGOTIATIONS AT COP29

Global context:

- Major elections year globally
- US and China enhancing cooperation – but new envoys this year
- Energy supply crisis with spill-over effects
- Wars e.g. Ukraine and Gaza

COP29:

- Hosted in fragile Eastern European region
- Announcement of COP Presidencies Troika with UAE, Azerbaijan and Brazil.
- Major decisions to be taken in Baku
 - New climate finance goal
 - Update of NDCs including features



NEW COLLECTIVE QUANTIFIED GOAL ON CLIMATE FINANCE

- New post-2025 global climate finance goal should be adopted from a floor of USD 100 billion per year
- High-Level Expert Group on Climate Finance estimates that USD 2.4tn from 2030 onwards will be needed for mitigation, adaptation and addressing loss and damages in EMDCs.
- Discussions revolve around the quantum, the timeframe, the issue of sub-targets etc.



NATIONALLY DETERMINED CONTRIBUTIONS (NDC)

- Parties to present next round of NDCs 9-12 months prior to COP30 in Brazil
- NDCs should have a time horizon of 2035, be more ambitious than the earlier NDC, and be informed by GST.
- NDCs are a cornerstone in the Paris Agreement – bottom-up approach.
- G20 countries responsible for 80 % of global GHG emission. 2024 and COP29 is a key moment to create momentum and apply pressure on major emitters.
- COP29 – guidance on features.



DANISH AND EU PRIORITIES

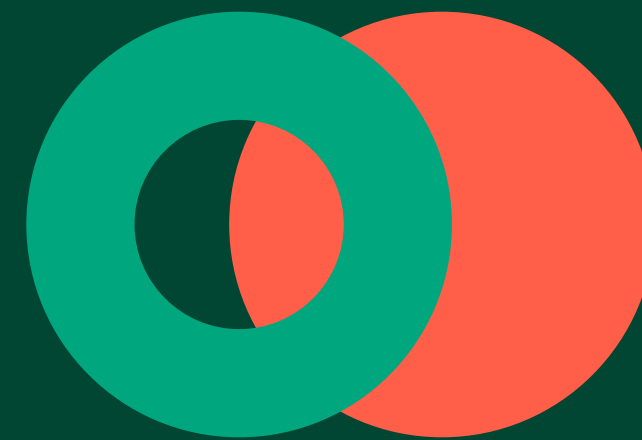
- Danish priorities
 - Push for increased ambition and implementation of current and new NDCs – both through negotiations and action track. Mobilizing pressure on G20 countries.
 - Finance: Delivering a finance goal which utilizes all financial sources and instruments, in order to unlock finance and investments needed to implement ambitions, incl. from COP28,
- EU mandate/priorities:
 - Technical positions leading up to technical negotiation session in Bonn – June 2024
 - Political mandate: Council conclusions in the fall 2024

Businesses for climate action

Businesses play a key role in the green transition

- Though governments agree on the framework for climate action, the actual green transition takes place within the companies
- Danish companies provide world leading solutions needed for mitigation & adaptation
- Businesses are an important partner in driving climate finance, which will be the key theme at COP29
- Businesses provide the solutions of tomorrow with R&D
- Businesses are important climate ambassadors to enhance knowledge transfer to other countries

The Danish case: Public-private partnerships for climate action

- The Danish climate change leadership is built on public-private partnerships (PPPs)
- PPPs support a fast and effective delivery on climate goals
- A united delegation with shared priorities at COP29: We can present learnings and concrete climate pathways to world leaders and key stakeholders in the blue zone
- PPPs work all year round to prepare for COP29: From Copenhagen Ministerial, to Petersberg Climate Dialogue, to spring meetings held by the World Bank and the International Monetary Fund on climate finance, to Bonn Climate Change Conference, to New York Climate Week, before we finally travel to Baku in November

Priorities at COP29

Continuing the momentum from COP28

- How do we best follow up on the key points from the Global Stocktake text from COP28 with a transition away from fossil fuels, tripling of renewable energy, doubling energy efficiency?
- Public-private partnerships for climate action: Denmark is leading by example with its 14 climate partnerships united in the effort to increase climate action.
- With strong focus on climate action enablers such as renewable energy and energy efficiency, Denmark is leading the way in upholding the final agreement text from COP28 and keeping up the momentum.
- Jointly we can discuss how the private sector can continue to be a leading force in accelerating the shift from fossil fuels to renewable energy.

Mobilising climate finance for climate action

- Climate finance is the greatest enabler of climate action.
- The Climate Policy Initiative (CPI) estimates that approximately an average of USD 8,6 trillion of global climate finance will be needed every year until 2030 in order to align with the 1,5-degree Paris-agreement target.
- Climate finance pledges have been made by both the public and private sector in Denmark, but more will be needed. At the same time, we need to ensure climate finance is used to transition away from fossil fuels and towards renewable energy.
- Jointly we can discuss how we can derisk climate finance to mobilise the climate finance needed to effectively combat climate change at home and abroad, and for both mitigation and adaptation efforts.

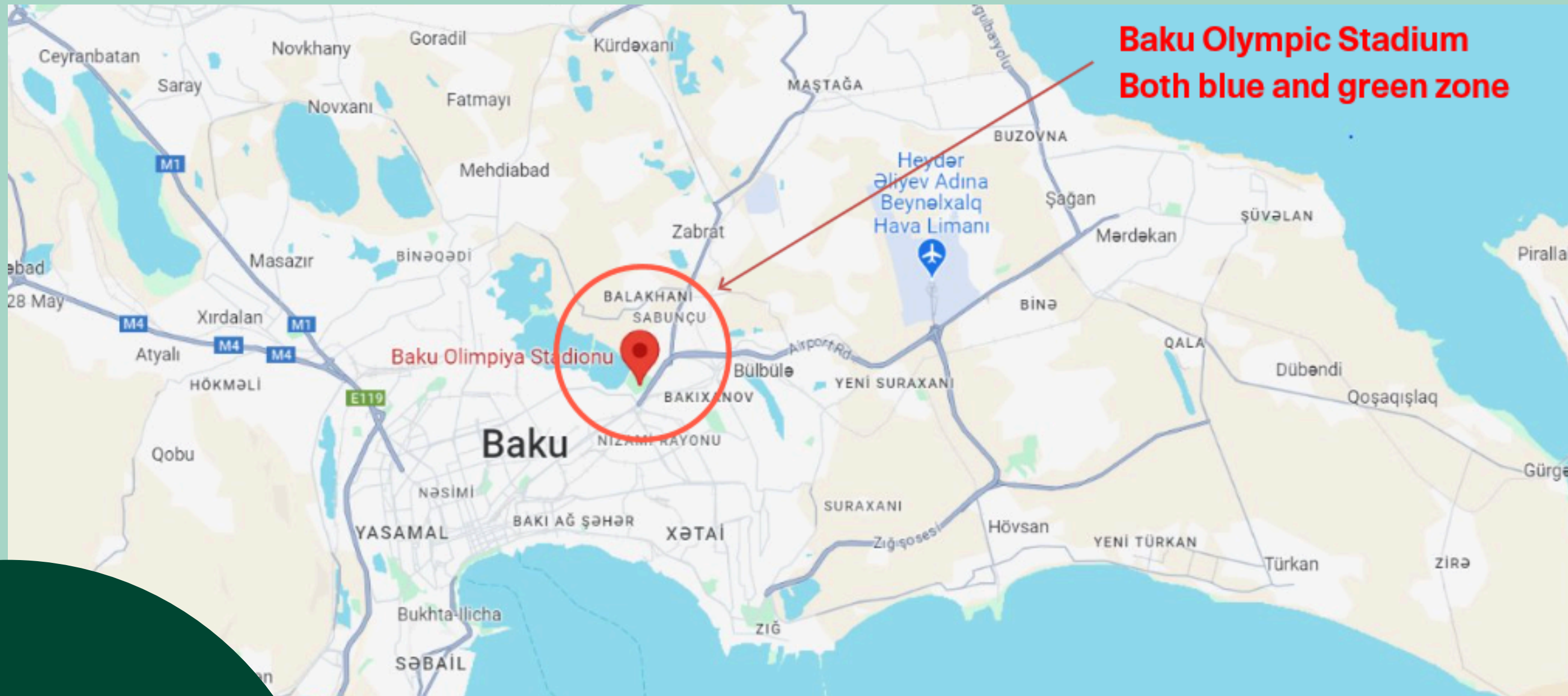

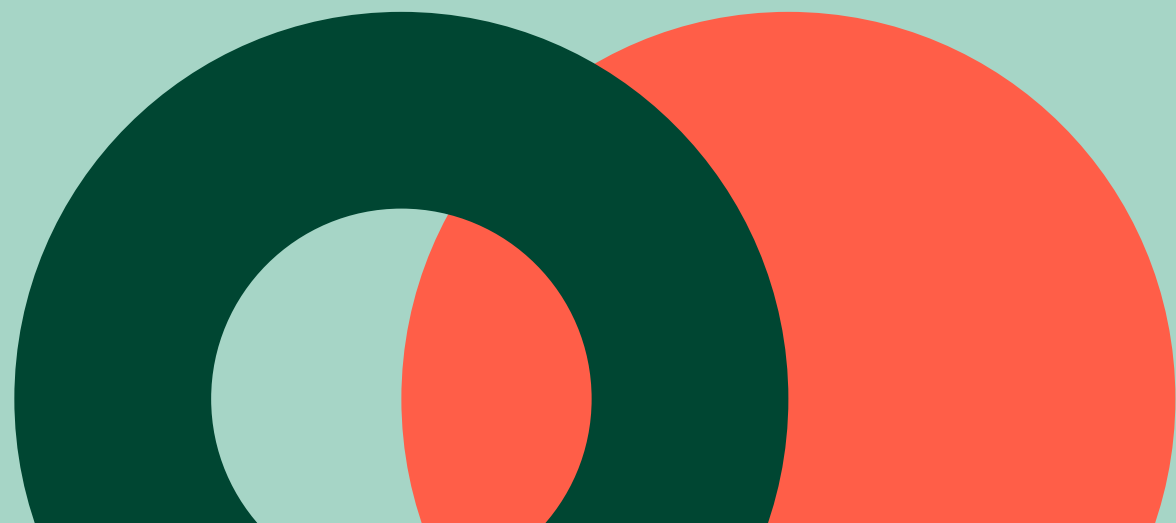


We expect a smaller COP than in Dubai. Logistic capacity maybe half of Dubai.

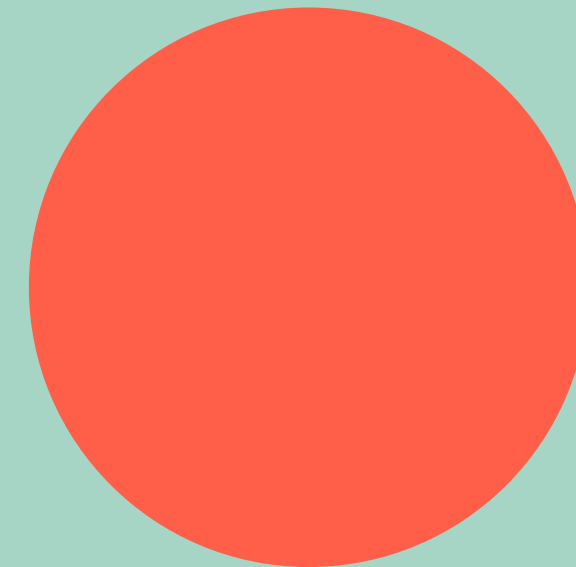

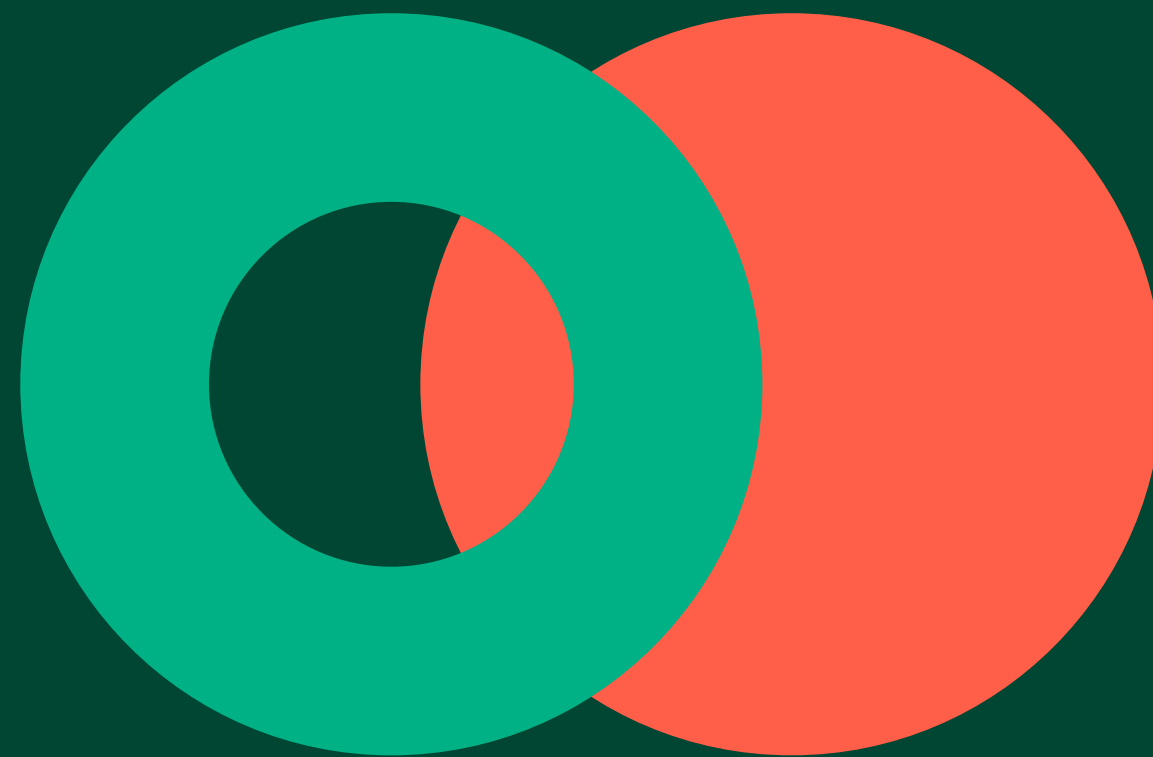
